L. B. & M.; thence S 84° 56' W 206.00 feet.

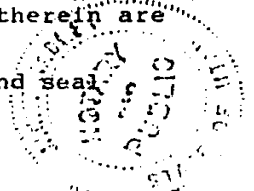

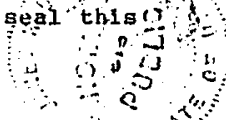
