DEED OF TRUST, ASSIGNMENT, SECURITY AGREEMENT AND FIXTURE FILING

THIS DEED OF TRUST, ASSIGNMENT, SECURITY AGREEMENT AND FIXTURE FILING dated November 20, 2019 (together with any amendments or modifications hereto in effect from time to time, the "Security Instrument"), is made by (i) RSF AV ST. 

CONDITIONS TO GRANT

TO HAVE AND TO HOLD the above granted and described Property unto and to the use and benefit of Administrative Agent and its successors and assigns, for the benefit of itself and the Lenders, forever;

- Future Advances, Administrative Agent or the Lenders may from time to Section 2.2 time, pursuant to the Loan Agreement and the other Loan Documents, make optional future or ádditional advances ("<u>Future Advances"</u>) to or for the benefit of Trastor, which Future Advances (shall be secured by this Security Instrument, including, without limitation: (a) principal, interest late charges, fees and other amounts which Administrative Agent or any Lender may advance pursuant to the Loan Documents; (b) all advances by Administrative Agent to or for the benefit of Trustor or any other person to pay costs of erection, construction, alteration, repair, restoration, maintenance and completion of any improvements on the Property; (c) all advances made or costs incurred by Administrative Agent for the payment of real estate taxes, assessments or other governmental charges, maintenance charges, insurance premiums, appraisal charges, environmental inspection, audit, testing or compliance costs, private assessments or maintenance costs, and costs incurred by Administrative Agent for the enforcement and protection of the Property or the lien and security title of this Security Instrument; and (d) all legal fees, costs and other expenses incurred by Administrative Agent by reason of any default or otherwise in connection with the Obligations. All the covenants, conditions and agreements contained in (a) the Loan Agreement, (b) the Notes and (c) all and any of the other Loan Documents, are hereby made a part of this Security Instrument to the same extent and with the same force as if fully set forth herein
- Insurance Trustor shall obtain and maintain, or cause to be maintained, in Section 3.3 full force and effect at all times insurance with respect to Trustor and the Property as required pursuant to the Loan Agreement.
- Section 3.4 Maintenance of Property. Trustor shall (a) cause the Property to be maintained in a good and safe condition and repair; (b) make or cause to be made, as and when necessary, all repairs, replacements and additions, whether or not insurance proceeds are available therefor; and (c) not remove, demolish, materially alter, discontinue the use of permit to become vacant or deserted, or otherwise dispose of all or any material part of the Property (except for normal replacement of the Fixtures, the Equipment or the Personal Property and refurbishment of the Improvements), except as expressly permitted under the terms of the Loan Agreement and the other Loan Documents. Subject to the terms of the Loan Agreement, Trustor shall promptly repair. replace or rebuild any part of the Property which may be destroyed by any casualty or become damaged, worn or dilapidated or which may be affected by any condemnation. All alterations, replacements, renewals or additions made pursuant hereto shall automatically become a part of the Property and shall be covered by the lien of this Security Instrument. Administrative Agent, and any persons authorized by Administrative Agent, shall have the right, but not the obligation, to enter upon the Property at any reasonable time to inspect and photograph its condition and state of repair as provided in the Loan Agreement. In the event any such inspection reveals, in the reasonable discretion of Administrative Agent, the necessity for any repair, alteration, replacement, clean-up or maintenance, Trustor shall, at the discretion of Administrative Agent, either: (i) cause such work to be effected promptly; or (ii) promptly establish an interest bearing reserve fund with Administrative Agent in an amount determined by Administrative Agent for the purpose of effecting such work.

Trustor hereby covenants that Trustor shall (a) preserve such title and the validity and priority of the lien of this Security Instrument and shall forever warrant and defend the same to Administrative Agent against all lawful claims whatsoever, subject to the Permitted Encumbrances; and (b) execute, acknowledge and deliver all such further documents or assurances as may at any time hereafter be required by Administrative Agent to protect fully the lien of this Security Instrument.

Taxes and Other Charges. Trustor shall promptly pay and discharge all Section 3.9 taxes, assessments, water and sewer rents, and other governmental charges imposed upon the Property ("Taxes") when due, as more particularly required pursuant to Section 2.11 of the Loan Agreement.

Escrows. If required by Administrative Agent during the existence of an Event of Default, Trustor shall pay to Administrative Agent at the time of each installment of interest due under the Loan Agreement, and commencing with the first payment due after the date of such request, a sum equal to (a) the amount of the next installment of Taxes on the Property, and/or (b) the premiums which will next become due on the insurance policies required by the Boan Agreement, all in amounts as estimated by Administrative Agent, less all sums already paid 7 therefor or deposited with Administrative Agent for the payment thereof, divided by the number of payments to become due before one (1) month prior to the date when such Taxes and/or premiums, as applicable, will become due, such sums to be held by Administrative Agent to pay the same when due. - Section 4.2 No Reliance on Administrative Agent. The general partners, members, principals and (if Trustor is a trust) beneficial owners of Trustor, as applicable, are experienced in the ownership and operation of properties similar to the Property, and Trustor and Administrative Agent are relying solely upon such expertise and business plan in connection with the ownership and operation of the Property Trustor is not relative. and operation of the Property? Trustor is not relying on Administrative Agent's or any other Lender's expertise, business acumen or advice in connection with the Property.

Section 4.3 Limitation of Agent Obligations

- (a) Notwithstanding anything hetein to the contrary, Administrative Agent is not undertaking the performance of (i) any obligations under the Leases; or (ii) any obligations with respect to any other agreements, contracts, certificates, instruments franchises, permits, trademarks, licenses or other documents.
- By accepting or approving anything required to be observed, performed or fulfilled or to be given to Administrative Agent pursuant to this Security Instrument, the Loan Agreement, the Notes or the other wan Documents, including, without limitation, any officer's certificate, balance sheet, statement of profit and loss or other financial statement, survey, appraisal, or insurance policy, Administrative Agent shall not be deemed to have warranted, consented to, or affirmed the sufficiency, the legality or the effectiveness of same, and such acceptance or approval thereof shall not constitute any warranty or affirmation with respect thereto by Administrative Agent

Section 4.4 Reliance. Trustor recognizes and acknowledges that in accepting the Loan Agreement, the Notes, this Security Instrument and the other Loan Documents, Administrative Agent and each Lender is expressly and primarily relying on the truth and accuracy of the warranties and representations set forth in the Loan Agreement without any obligation to investigate the Property and notwithstanding any investigation of the Property by Administrative Agent or any Lender; that such reliance existed on the part of Administrative Agent and each Dender prior to the date hereof that the warranties and representations are a material inducement. To to Administrative Agent and each Lender in making the Loan; and that each Lender would not be willing to make its Loan and accept this Security Instrument in the absence of the warranties and representations as set forth in the Loan Agreement.

ARTICLE V FURTHER ASSURANCES

Section 5.1 Recording of Security Instrument, Etc. Trustor forthwith upon the execution and delivery of this Security Instrument and thereafter, from time to time, will cause this Security Instrument and any of the other Loan Documents conveying, creating or evidencing the security title, liens or security interest hereof upon the Property and each instrument of further assurance to be filed, registered or recorded in such manner and in such places as may be required by any present or future law in order to publish notice of and fully to protect and perfect the security title, liens or security interest hereof upon, and the interest of Administrative Agent in, the Property. Trustor will pay all taxes, filing, registration or recording fees, and all expenses incident to the preparation, execution, acknowledgment and/or recording of any Note, this Security Instrument, the other Loan Documents, any note, deed of trust or mortgage supplemental hereto. any Security Instrument with respect to the Property and any instrument of further assurance, and any modification or amendment of any of the foregoing documents, and all federal, state, county and municipal taxes, duties, imposts, assessments and charges arising out of or in connection with the execution and delivery of this Security Instrument, any deed to secure debt, deed of trust or mortgage supplemental hereto, any Security Instrument with respect to the Property or any instrument of further assurance, and any modification of amendment of any of the foregoing documents, except where prohibited by law so to do.

Section 5.2 Further Acts, Etc. Trustor will, at the cost of Trustor, and without expense to Administrative Agent or any Lender, do, execute, acknowledge and deliver(all and every such further acts, deeds, conveyances, security deeds, deeds of trust, mortgages, assignments, notices of assignments, transfers and assurances as Administrative Agent shall, from time to time, reasonably require, for the better assuring, conveying, assigning, transferring, and confirming unto Administrative Agent the propertional rights hereby deeded, granted, bargained, sold, conveyed, confirmed, pledged, assigned, warranted and transferred or intended now or hereafter so to be, or which Trustor may be or may hereafter become bound to convey or assign to Administrative Agent, or for carrying out the intention or facilitating the performance of the terms of this Security Instrument or for filing, registering or recording this Security Instrument, or for complying with all Applicable Law. personal property of Trustor" or words of similar effect, in order to perfect the security title and interests granted by Trustor under this Security Instrument. Trustor grants to Administrative Agent an irrevocable power of attorney coupled with an interest for the purpose of exercising and perfecting any and all rights and remedies available to Administrative Agent at law and in equity, including without limitation such rights and remedies available to Administrative Agent pursuant to this Section 5.2.

Section 5.3 Changes in Tax, Debt, Credit and Documentary Stamp Laws.

- If any Applicable Law is enacted or adopted or amended after the date of this (a) Security Instrument which deducts the Debt from the value of the Property for the purpose of taxation or which imposes a tax, either directly or indirectly, on the Debt or Administrative Agent's interest in the Property, Trustor will pay the tax, with interest and penalties thereon, if any. If Administrative Agent is advised by counsel chosen by it that the payment of tax by Trustor would be unlawful or taxable to Administrative Agent or unenforceable or provide the basis for a defense of usury, then Administrative Agent shall have the option by written notice of not less than one aundred twenty (120) days to dectare the Debt immediately due and payable.
- Trustor will not claim or demand or be entitled to any credit or credits on account (b) of the Debt for any part of the Taxes assessed against the Property, or any part thereof, and no deduction shall otherwise be made or claimed from the assessed value of the Property, or any part thereof, for real estate tax purposes by reason of this Security Instrument or the Debt. If such claim, credit or deduction shall be required by Applicable Law, Administrative Agent shall have the option. Wy written notice of not less than one hundred twenty (120) days to declare the Debt immediately due and payable.
- If at any time the United States of America, any State thereof or any subdivision of any such State shall require revenue or other stamps to be affixed to any Note, this Security. Instrument, or any of the other Loan Documents or shall impose any other tax or charge on the same, Trustor will pay for the same, with interest and penalties thereon, if any.
- Section 5.4 Splitting of Security Instrument. Each Note may, at any time until the same shall be fully paid and satisfied, at the sole election of Administrative Agent, be split or divided into two or more notes, each of which shall cover all or a portion of the Debt to be more particularly described therein. To that end, Trustor upon written request of Administrative Agent, shall execute, acknowledge and deliver, or cause to be executed, acknowledged and delivered by the then owner of the Property, to Administrative Agent and/or its successors or assigns permitted by the Loan Agreement, substitute notes in such principal amounts, aggregating not more than the then unpaid principal amount of the Notes, and containing terms provisions and clauses identical to those contained in the Notes.

ARTICLE 6 DUE ON SALE/ENCUMBRANCE

Section 6.1 Reliance. Trustor acknowledges that Administrative Agent and each Lender has examined and relied on the experience of Trustor and its general partners, managers, members, principals and beneficial owners in owning and operating properties such as the Property

in agreeing to make the Loan, and will continue to rely on Trustor's ownership of the Property as a means of maintaining the value of the Property as security for the repayment of the Debt and the payment and performance of the other Obligations. Trustor acknowledges that Administrative Agent and each Lender has a valid interest in maintaining the value of the Property so as to ensure that should there be an Event of Default. Administrative Agent can recover the Debt and the other Obligations by a sale of the Property for the benefit of itself and the Lenders.

> Section 6.2 No Transfer or Encumbrance. Except as expressly permitted in the Loan Agreement, Trustor shall not permit or suffer any Transfer of the Property. Except as expressly permitted under the Loan Agreement, Trustor will not permit the Property to become subject to any lien, easement, right of way, roadway (public or private), common area, condominium regime, cooperative housing regime, restrictive covenant, Lease or other matter of any nature that would affect title to the Property, other than the Permitted Encumbrances.

ARTICLE VII EVENTS OF DEFAULT; REMEDIES

Event of Default. Each of the following shall constitute an event of default Section 7.1 (each, an "Event of Default") hereunder:

- An Event of Default (as defined therein) occurs under the Loan Agreement; (a)
- Trustor fails to promptly perform or comply with any of the obligations set forth in this Security Instrument, and such failure continues beyond that date which is thirty (30) days after the earlier of (i) the date on which Administrative Agent notifies Trustor of such failure or (ii) the date on which Trustor otherwise becomes aware of such failure;
- A default or every of default occurs under any of the Notes or any other Loan (c) Document other than the Loan Agreement, and such default or event of default continues beyond the expiration of the applicable grace or notice and cure period therefor, if any, set forth in such Loan Document (without duplication); or
- An event of default occurs under any of the Ovation Loan Documents as defined in the Loan Agreement);
- Section 7.2 Remedies. If an Event of Default shall have occurred and shall be continuing, Administrative Agent may, or at the direction of the Required Lenders, shall, take any of the following actions:
- Acceleration. Administrative Agent may declare the entire amount of the Debt immediately due and payable, without presentment, demand, notice of any kind, protest or notice of protest, all of which are expressly waived, notwithstanding anything to the contrary contained in any of the Loan Documents. Administrative Agent may in accordance with the Loan Agreement charge and collect interest at the Default Rate from the date of default on the unpaid balance of the Debt, at the rate set forth in the Loan Agreement.
- Possession. To the extent permitted by Applicable Law, Administrative Agent may enter upon and take possession of the Property, with or without legal action, lease the Property,

collect therefrom all rentals and, after deducting all costs of collection and administration expense, apply the net rentals to any one or more of the following items in such manner and in such order of priority as provided in the Loan Agreement; the payment of any sums due under any prior lien, taxes, water and sewer rents, charges and claims, insurance premiums and all other carrying charges to the maintenance, repair of restoration of the Property, or on account of the Obligations. Subject to Applicable Law, Administrative Agent is given full authority to do any act which Trustor could do in connection with the management and operation of the Property. This covenant is effective either with or without any action brought to foreclose this Security Instrument and without applying for a receiver of such rents. If, following written notice from Administrative Agent to Trustor to yacate and surrender the Property Trustor does not vacate and surrender the Property then Trustor may be evicted by summary proceedings in accordance with applicable law.

- Foreclosure and Sale. Administrative Agent may cause the Property which consists solely of real property to be sold by Trustee as permitted by applicable law. Before any such trustee's sale, Trustee shall give such portice of default and/or sale as may then be required by law. When all time periods then legally mandated have expired, and after such notice of sale as may then be legally required has been given, and all other requirements required by Applicable Law have been satisfied, Trustee shall sell the Property, either as a whole or in separate parcels, and in such order as Trustee may determine (but subject to Trustor's statutory right under Utah Code Annotated § 57-1-27 to direct the order in which the property, if consisting of several known lots or parcels, shall be sold), at a public auction to be held at the time and place specified in the notice of sale (as such time of sale may be postponed pursuant to Utah Code Annotated \$ 57-1-27). Neither Trustee nor Administrative Agent shall have any obligation to make demand on Trustor before any trustee's sale. From time to time in accordance with then applicable law, Trustee may, and in any event at Administrative Agent's request shall, postpone any trustee's sale by public announcement at the time and place noticed for that sale. At any trustee's sale, Trustee shall sell to the highest bidder at public auction for cash in lawful money of the United States, or such other form of payment satisfactory to Trustee and permitted by applicable law. Any person, including Trustor, Trustee or Administrative Agent, may purchase at the trustee's sale to the extent permitted by then applicable law. Administrative Agent shall have the benefit of any law permitting credit bids. Trustee shall execute and deliver to the purchaser(s) a deed or deeds conveying the property being sold without any covenant or warranty whatsoever, express or implied. The recitals in any such deed of any matters or facts, including any facts bearing upon the regularity or validity of any trustee's sale, subject to applicable law, shall be conclusive proof of their truthfulness. Any such deed shaft, subject to applicable law, be conclusive against all persons as to the facts recited in it.
- Appointment of Receiver. Administrative Agent may petition a court of competent junisdiction to appoint a receiver of the Property. Such appointment may be made either before or after sale, without notice, without regard to the solvency or insolvency of Trustor at the time of application for such receiver, without regard to the then value of the Property or whether the Property shall be then occupied as a homestead or not, and without regard to whether Trustor has committed waste or allowed deterioration of the Property, and Administrative Agent or any agent of Administrative Agent may be appointed as such receiver. Trustor hereby agrees that Administrative Agent has a special interest in the Property and absent the appointment of such receiver the Property may suffer waste and deterioration and Trustor further agrees that it shall not contest the appointment of a receiver and hereby so stipulates to such appointment pursuant to this paragraph. Such receiver shall have the power to perform all of the acts permitted Administrative
