AN ORDINANCE

AN ORDINANCE VACATING a portion of Fifth West Street between Second and Third South Streets, all abutting property owners having petitioned for the vacation.

Be it ordained by the Board of Commissioners of Salt Lake City, Utah:

SECTION 1. That a portion of Fifth West Street between Second and Third South Streets, more particularly described as follows, be and the same hereby is, vacated and declared no longer to be public property for use as a street, avenue, alley or pedestrian way:

"Commencing at the Northwest corner of Lot 6, Block 63, Plat "A", Salt Lake City Survey; Thence South 660.0 feet to the Southwest corner of Lot 2 of said Block 63; thence West 4.0 feet; thence North 660.0 feet; thence East 4.0 feet to the point of beginning."

Said vacation is made expressly subject to all existing rights of way and easements of all public utilities of any and every description now located in, on, under or over the confines of the above described property; and also subject to the rights of entry thereon for the altering or rerouting said utilities and all of them.

SECTION 2. In the opinion of the Board of Commissioners, it is necessary to the peace, health and safety of the inhabitants of Salt Lake City, Utah, that this ordinance become effective immediately.

SECTION 3. This ordinance shall take effect upon its first publication.
