AN ORDINANCE
AN ORDINANCE VACATING FLORAL
Street between 2nd and 3rd South
Streets in Salt Lake City, Utah.
Be it ordained by the Board of
Commissioners of Salt Lake City,
Utah:

SECTION 1. That Floral Street
between 2nd and 3rd South Streets
in Salt Lake City, Utah, more par-
ticularly described as follows:

Beginning at a point 77 ft. west
from the southeast corner of Lot
3, Block 56, Plat "A," Salt Lake
City Survey, thence north 156
ft., thence west 2 ft., thence
north 150 ft., thence west 9 ft.,
thence north 84 ft., thence east
7 ft., thence north 86 ft., thence
west 15 ft., thence north 43 ft.,
thence east 15 ft., thence north
185 ft., thence west 15 ft., thence
south 130 ft., thence east 2 ft.,
thence south 200 ft., thence east
2 ft., thence south 142 ft., thence
east 8 ft., thence south 155 ft.,
thence east 10 ft., to the place
of beginning;

and the same is hereby vacated
and declared no longer to be public
property for use as a street, avenue,
alley or pedestrian way.

Said vacation is made expressly
subject to all existing rights of way
and easements of all public utilities
of any and every description now
located on, in, under or over the con-
fines of the above described prop-
erty and also subject to the right of
entry thereon for the purpose of in-
specting, maintaining, repairing, re-
placing, removing, altering or re-
routing said utilities and all of them.

SECTION 2. In the opinion of the
Board of Commissioners, it is neces-
sary to the peace, health and safety
of the inhabitants of Salt Lake City
that this ordinance shall become
effective immediately.

SECTION 3. This ordinance shall
take effect upon its first publication.
Passed by the Board of Commis-
sioners of Salt Lake City, Utah, this
29th day of April, A.D. 1948.
