Also Commencing Nine 12-1/2/100 (9.12-1/2) Chains East and Nineteen 70/100 (19.70) Chains South 1° West of the North West Corner of the Northeast Quarter (1/4) of Section Eight (8), Township Nine (9) South, Range Two (2) East, aforesaid; thence South 1° West Nineteen 71/100 (19.71) chains, thence South 89° East One 98/100 (1.98) Chs. Thence North 1° East Nineteen 71/100 (19.71) Chains, thence North 89° West One 98/100 (1.98) Chains, to the place of beginning.
