
NOTICE OF CERTIFICATION AND LIEN

Pursuant to the authority of §17B-1-902, Utah Code Annotated, 2008 (the "Statute"), notice is hereby given that Snyderville Basin Water Reclamation District (the "District"), has certified to the Treasurer of Summit County, Utah, that as of this date there are past due fees and charges for wastewater service provided by the District to the following properties in the attached Lien List Exhibit A.

Under the Statute, past due fees and charges for water services provided by the District to the Property, together with applicable interest and penalties, upon certification become a lien on the Property on a parity with and collectible at the same time and in the same manner as general county taxes that are a lien on the Property.
