ORDINANCE NO. 96-06

AN ORDINANCE OF BRIGHAM CITY VACATING LOT 4 OF THE GEORGIA ESTATES SUBDIVISION AS SET FORTH IN EXHIBIT "A", LOCATED AT APPROXIMATELY 500 WEST 1050 BOUTH IN BRIGHAM CITY.

The Brigham City Council finds and determines that neither the public nor any person will be materially injured by the proposed partial vacation, that there is good cause for the partial vacation and that it is necessary for the preservation of the peace, health and safety of the inhabitants of Brigham City.
- 4. This Ordinance shall take effect upon recording at the Box Elder County Recorder's Office and an original and executed copy shall be recorded in the County Recorder's Office.
