Beginning at the east boundary line of the Grantors' land at a point one foot north, more or less, from the southeast corner of Lot 7, Block 30, Plat A, Salt Lake City Survey, thence S. 89° 58' W. 150 feet, more or less, to a fence on the west boundary line of said land and being in said Lot 7.
