UNDERGROUND RIGHT OF WAY EASEMENT

This Underground Right of Way Easement is executed this 18 day of September, 2015, by **University Mall Shopping Center, L.C.** ("Grantor"), and **Rocky Mountain Power**, an unincorporated division of Pacificorp ("Grantee").

WHEREAS, Grantor is the owner of Property depicted in Exhibit A attached hereto;

WHEREAS, Grantor previously granted to Grantee a ten (10) foot wide easement on Grantor's property, as established in that Underground Right of Way Easement dated July 28, 2015 and recorded July 30, 2015, as Entry No. 68745:2015 in the Utah County Recorder's Office (the "Original Easement");

WHEREAS, the Parties recognize and agree that the Original Easement will not adequately allow Grantee to perform the purposes for which the Original Easement was granted.

WHEREAS, Grantor and Grantee wish to enter into a new Easement Agreement and release the Original Easement.

NOW, THEREFORE, in consideration of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor and Grantee agree as follows:

1. The Underground Right of Way Easement dated July 28, 2015 by Grantor in favor of Grantee is hereby released, vacated and replaced in its entirety by this Underground Right of Way Easement.

2. For value received, Grantor, hereby grants to Grantee, a nonexclusive easement for a right of way 10 feet in width (location as described in legal description and Exhibit B), more or less, for the construction, reconstruction, operation, maintenance, repair, replacement, enlargement, and removal of underground electric power transmission, distribution and communication lines and all necessary or desirable accessories and appurtenances thereto, including without limitation: wires, fibers, cables and other conductors and conduits therefor; and pads, transformers, switches, cabinets, and vaults on, across, or under the surface of the real property of Grantor in **Utah** County,

State of **Utah** more particularly described as follows and as more particularly described and/or shown on Exhibit A attached hereto and by this reference made a part hereof:

A 10' wide easement along straight runs where applicable together with areas around electrical equipment. The perimeter of which is described as follows:

Together with the right of access to the right of way from adjacent lands of Grantor for all activities in connection with the purposes for which this easement has been granted; and together with the present and (without payment therefor) the future right to keep the right of way clear of all brush, trees, timber, structures, buildings and other hazards which might endanger Grantee's facilities or impede Grantee's activities.

3. At no time shall Grantor place or store any flammable materials (other than agricultural crops), or light any fires, on or within the boundaries of the right of way. Subject to the foregoing limitations, the surface of the right of way may be used for agricultural crops and other purposes not inconsistent, as determined by Grantee, with the purposes for which this easement has been granted.

4. Grantor reserves the right to terminate this easement if Grantee does not use the property for the purposes for which this easement has been granted.

5. Except for the initial restoration that is required upon the installation of Grantee's facilities within the Easement granted herein, Grantee shall restore a near as practicable to its previous condition, at no cost to Grantor, any pavement, landscaping, curb and gutter, or any other improvement damaged in constructing, maintaining, repairing, removing or replacing the facilities within such right-of-way.

6. The rights and obligations of the parties hereto shall be binding upon and shall benefit their respective heirs, successors and assigns.

7. Within fourteen (14) days after the completion of Grantee's initial construction, Grantee shall provide Grantor, at Grantor's sole cost and expense, with an as-built metes and bounds description prepared by a surveyor from a field-verified alignment. Upon completion of said as-built survey, in the event Grantee's facilities are found to be outside of the easement as described herein, Grantor agrees to amend the legal description of this easement to cover the actual location of all installed facilities, at sole cost to Grantor.

8. To the fullest extent permitted by law, each of the parties hereto waives any right it may have to a trial by jury in respect of litigation directly or indirectly arising out of, under or in connection with this agreement. Each party further waives any right to consolidate any action in which a jury trial has been waived with any other action in which a jury trial cannot be or has not been waived.

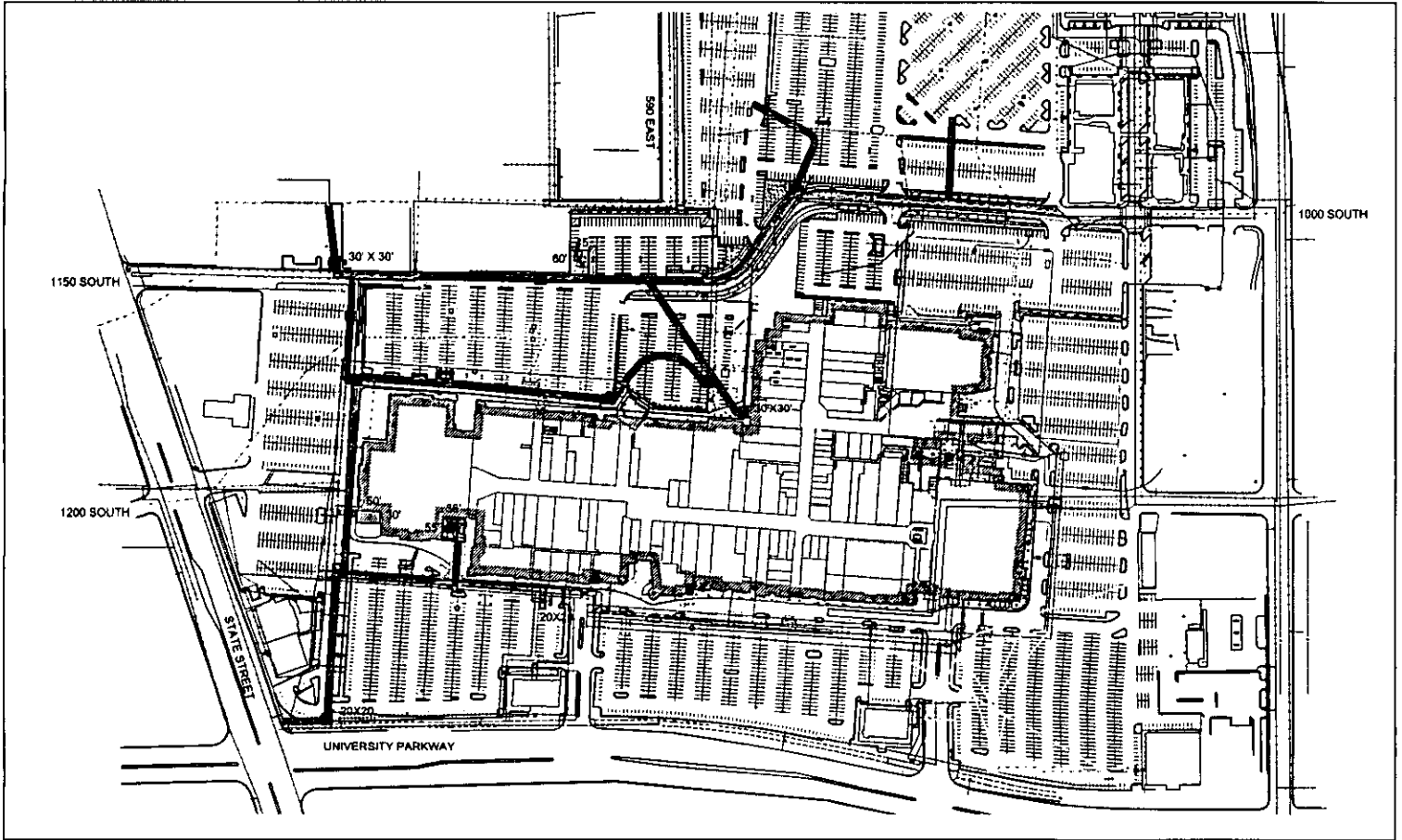
