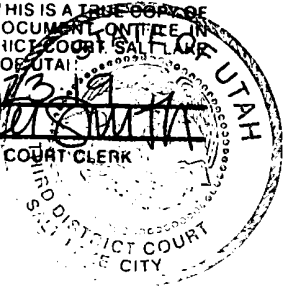

Defendants, Now Construction Services, LLC and Millcreek Cove Apartments, LLC, have failed to plead or otherwise defend in this action and default has been entered.

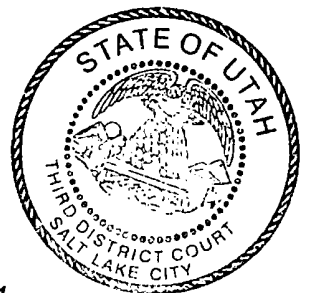
