WARRANTY DEED

MACA Supply Co., Inc., aka MACA Supply Co., Inc., a Utah corporation, pursuant to a resolution duly adopted by its board of directors, grantor of Utah County, State of Utah, hereby conveys to Clair Anderson & Mary Ann Anderson trustee(s) of the C. B. and M. A. Anderson Trust, of Utah County, State of Utah, grantee for and in consideration of Ten Dollars and other good and valuable consideration, the following described parcel of real property located within Springville City Industrial Park in Springville, Utah County, State of Utah:

Beginning at a point on the South right-of-way line of the Industrial Parkway Road which is South 1401.67 feet and West 1763.12 feet from the South quarter corner of Section 20, Township 7 South, Range 3 East, Salt Lake Base and Meridian; thence North 82 Degrees 26 Minutes 59 Seconds West 319.0 feet along the South right-of-way line of the Industrial Parkway road; thence South 7 Degrees 33 Minutes 1 second West 383.91 feet to the intersection with a fence line, which fence line is the South boundary line of the Springville Industrial park; thence South 73 Degrees 13 Minutes 39 Seconds East along said fence line 323.17 feet; thence North 7 Degrees 33 Minutes 1 second East 435.70 feet to the point of beginning. Containing 3.01 acres more or less.

Subject to the reservation by Springville City, a municipality of the State of Utah, a public utility easement 20 feet wide on the Southerly edge of said parcel and a public utility easement 15 feet wide on the Easterly edge of said parcel. Basis of bearing is occupying the South quarter corner of Section 20 and backsliding Spanish Fork Peak with a bearing of South 37 Degrees 7 Minutes East.

Subject also to the protective covenants adopted by Springville City on October 5, 1976, and recorded October 7, 1976, as Entry #26007 in Book 1504, Pages 87 through 95, of the records of the Utah County Recorder, and as corrected December 20, 1977, and recorded May 4, 1978, as Entry #17026 in Book 1643, Pages 177 through 178, of the records of the Utah County Recorder; and also subject to rights-of-way and easements of record or which are visible on inspection of the premises.
