Dollars to use the following described premises situated upon the grantors land in Lot 3 of Section 18, T. 2 S., R. 1 E., S. L. M.

in Salt Lake County, Utah, for the purpose of reconstructing ~~and operating~~ the same as an irrigation ditch and appurtenant parts thereof:

A parcel of land the boundaries of which are described as follows:

Beginning at the intersection of the northerly boundary line of said grantors land and the westerly right of way line of state highway known as Project No. U-119 at a point 52.5 ft. perpendicularly distant westerly from the center line of survey of said project. Said point being also approximately 656 ft. east and approximately 19 ft. south along said westerly right of way line from the NW corner of said Lot 3; thence westerly 114 ft. along said northerly boundary line; thence S. 2°30' W., 5 ft.; thence easterly 98 ft., more or less, to a point 10 ft. perpendicularly distant westerly from said right of way line; thence S. 2°30' W., 55 ft., more or less, to the southerly boundary line of said grantors land; thence easterly 10 ft., more or less, along said southerly boundary line to said westerly right of way line; thence northerly 60 ft., more or less, along said right of way line to the point of beginning. Above described parcel of land contains 0.025 acre, more or less.

After said irrigation ditch is reconstructed on above described premises at the expense of the Road Commission, the Cahoon-Maxfield Irrigation Company is thereafter granted the right to maintain and operate said irrigation ditch on the above described premises, and the Road Commission is thereafter relieved of any further claim or demand for costs, damages or maintenance charges which may accrue against said irrigation ditch or appurtenant parts thereof.
