This Amendment to the Declaration of Condominium of Waterbury Open Space Community is made this 19th day of June, 1984, pursuant to the provisions of Paragraph 12 of said Declaration and the Utah Condominium Ownership Act.

R E C I T A L S :

A. The Declaration of Condominium of Waterbury Open Space Community was recorded on June 22, 1973 as Entry Number 2548993 in Book 3356 at pages 23 to 59 of the official records of the Salt Lake County Recorder.

B. Said Declaration of Condominium affects the real property described in Exhibit "A" attached hereto and incorporated herein by this reference.

C. The Unit Owners representing more than two-thirds (2/3) of the undivided interests in the Common Areas have approved the Amendments to the Declaration of Condominium set forth hereinafter.

NOW THEREFORE, the Management Committee of Waterbury Open Space Community hereby certifies and states that the Declaration of Condominium of Waterbury Open Space Community is amended as follows:

1. Paragraph 6(f) is amended in its entirety to read as follows:

(f) Capital Improvements. There shall be no structural alterations, capital additions to, or capital improvements of, the Common Areas requiring an expenditure in excess of seven and one-half percent (7

1/2%) of the annual operating assessment without the prior approval of Unit Owners holding a majority of the voting power.

2. Exhibit "C" to the Declaration of Condominium is amended to read as specified in Exhibit "C" attached hereto and included herein by this reference.

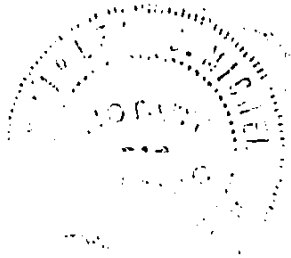
