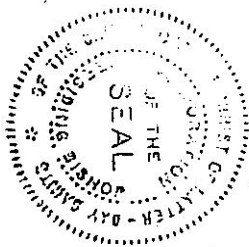
See Exhibit "A" attached hereto and by reference herein made a part hereof.

its corporate seal, by its authorized agent, this 4th day of May, 1993.

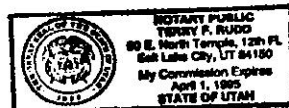

The land referred to in this commitment is situated in the County of Utah, State of Utah and is described as follows:

Beginning at a point in the Easterly right-of-way fence line of Redwood Road, Utah County, which point is South 3.319 feet and west 95.119 feet (Based on the Utah State Coordinate System, Central Zone) from the North quarter corner of Section 14, Township 5 South, Range 1 West, Salt Lake Base and Meridian; thence North 74° 27' 00" East 1476.10 feet to a fence line, thence along said fence line as follows: South 00° 35' 11" West 774.80 feet, South 00° 52' 43" West 321.73 feet, South 01° 00' 27" West 622.23 feet to the North line of a County Road, thence South 89° 59' 57" West along said County Road 465.94 feet; thence North 73° 32' 19" West 700.00 feet; thence South 26° 07' 41" West 200.55 feet to a fence line on the Easterly side of Redwood Road; thence along said fence line as follows: North 35° 35' 12" West 51.57 feet, North 19° 27' 35" West 16.21 feet, northerly around the periphery of a curve having a radius of 6200.60 feet and an interior angle of 11° 37' 00" for a distance of 1257.04 feet to the point of beginning, (the chord of which is North 6° 16' 51" West 1254.89 feet to the place of beginning.)
