TRANSFER AND CONVEYANCE

The State of Utah, acting through the BOARD OF WATER RESOURCES, formerly known as the Utah Water and Power Board, GRANTOR, for the full payment of the purchase price of the Agreement dated June 27, 1963 and amended June 25, 1964 and November 13, 1964, with the Moon Lake Water Users Association a corporation of the State of Utah, receipt of which is hereby acknowledged, hereby transfers and conveys to the MOON LAKE WATER USERS ASSOCIATION, GRANTEE, all right, title, and interest which the Board of Water Resources holds in the following-described easement in Duchesne County, Utah:

An easement to use the irrigation distribution systems of the Water Companies comprising the Moon Lake Water Users' Association, said Companies being the Dry Gulch Irrigation Company, Farnsworth Canal and Reservoir Company, Lake Fork Irrigation Company, Lake Fork Western Irrigation Company, Monarch Canal and Reservoir Company, South Bonita Irrigation Company, Uteland Ditch Company, T.N. Dodd Irrigation Company.

The irrigation distribution systems of the said companies lie in the Uintah Basin of the State of Utah in the following subdivisions of land all referenced to the Uintah Special Meridian:

T1S, R5W T1S, R4W T1S, R3W T1S, R2W T1N, R1W T1S, R1E
T2S, R5W T2S, R4W T2S, R3W T2S, R2W T1S, R1W T2S, R1E
T3S, R3W T3S, R2W T2S, R1W
T1N, R2W T3S, R1W

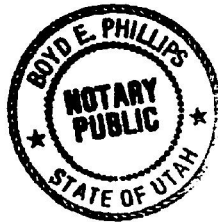
