CONVEYANCE OF PROPERTY AND EASEMENT

The Dry Gulch Irrigation Company of Duchesne County, Utah, Grantor, does hereby convey and warrant to the Utah Water and Power Board, Grantee, for good and valuable consideration, receipt of which is hereby acknowledged, the full title to the following dam and reservoir, known as the Atwood Lake Reservoir, all of which is embraced within the following described plat:

Commencing at a point which is 3203 feet north and 772 feet west from the SE Cor. of Section 14, T4N., R4W., Uintah Special Base and Meridian, running thence N 13°30'W., 700.0 ft., N 60°30' W - 2910.0 ft., N 64°30' W - 2330.0 ft., S 43°40' W - 2670.0 ft., S 43°00' E - 385.0 ft., East - 1150.0 ft., N 45°30' E - 1130.0 ft., N 60°00' E - 840.0 ft., S 96°30' E - 550.0 ft., S 56°30' E - 855.0' South 250.0 ft., East - 1965.0 ft., N 05°30' W - 1005.0 Ft., to beginning.

The above grantor does also grant to the Utah Water and Power Board an easement to the full use of the irrigation distribution system of the Dry Gulch Irrigation Company through which the water of Atwood Lake Reservoir and other reservoirs of the Irrigation Company are put beneficial use.
