South, Range 1 West, Salt Lake Base and Meridian, according to the official plat thereof on file and in the office of the Salt Lake County Recorder. The boundaries of said tract are described as follows:

BEGINNING at a point 298.489 feet North 00°18'11" East from the Southeast corner of Lot 1, Welby Manufacturing Phase 2A, thence North 89°54'00" West 384.326 feet to the Easterly line of Welby Park Drive; thence along said street as follows: Northeasterly 187.100 feet around the periphery of a curve to the right concave Southeasterly having a radius of 200.00 feet (chord - North 30°18'11" East 200.00 feet); thence North 60°18'11" East 168.20 feet; thence Northeasterly 278.184 feet around the periphery of a curve to the left having a radius of 260.00 feet (chord - North 29°39'05" East 265.10 feet); thence North 01°00'00" West 9.62 feet; thence North 02°29'50" East 196.53 feet; thence North 1°00'00" West 10.38 feet; thence Northwesterly 126.21 feet around the periphery of a curve to the left concave Westerly having a radius of 240.00 feet (chord - North 16°03'53" West 124.76 feet); thence Northeasterly 62.37 feet around the periphery of a curve to the right having radius of 40.00 feet (chord - North 13°32'32" East 56.24 feet) to the Southerly line of the New Bingham Highway; thence North 58°12'50" East along said highway line 29.72 feet to the East line of said Lot 1; thence South 00°18'11" West 871.348 feet along said East line to the point of beginning.
