## **KIGHT-OF-WAY EASEMENT**

A five foot (5') easement being 2.5 feet on either side of a buried telephone cable over the following described property: A part of the Southeast Quarter of Section 5, Township 5 North, Range 1 West, Salt Lake Meridian, U. S. Survey; Beginning at a point North 20.61 chains and West 1,627.53 feet from the Southeast corner of the said quarter section and running thence West 130.19 feet; thence South 165 feet; thence West 330.52 feet; thence North 13° East 470.58 feet; thence East 138.6 feet; thence North 53° East to the South line of Lot 17, Block 26, Lakeview Addition Subdivision; thence East to the West line of Grant Avenue; thence South 0°58' West 326.70 feet to the point of beginning.
