of South Jordan, County of Salt Lake State of Utah,  
hereby GRANTS AND CONVEYS to SALT LAKE CITY PUBLIC UTILITIES, a municipality organized and existing pursuant to Utah law, Grantee, for the sum of Ten Dollars,  
a perpetual easement upon part of an entire tract of property situate in part of Block 1, Lot 8 of the Charles S. Desky's Fifth Addition, a subdivision in the SE $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 34, Township 1 North, Range 1 West, Salt Lake Base and Meridian, State of Utah, for the purpose of constructing and maintaining thereon sanitary sewer lines and appurtenant parts thereof. The easement shall run with the Real Property and shall be binding upon the Grantor and the Grantors successors, heirs and assigns. The boundaries of said part of an entire tract are described as follows:

Beginning at a point 1.00 foot N.00°08'36"W. along the westerly boundary line of said Lot 8 and 11.70 feet N.89°55'19"E. from the Southwest corner of said Block 1; and running thence North 7.25 feet; thence N.89°55'19"E. 16.50 feet; thence South 7.25 feet; thence S.89°55'19"W. 16.50 feet to the point of beginning.

The above described part of an entire tract contains 120 square feet in area or 0.003 acre.

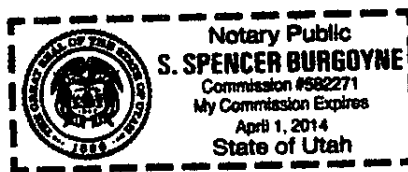
