

Said closure is expressly made subject to all existing rightof-ways and easements of all public utilities of any and every description now located on, under, or over the confines of the above described property, and also subject to the rights of entry thereon for the purposes of maintaining, altering, repairing, removing, or rerouting said utilities including the City's water and sewer facilities and all of them. Said closure is subject to any existing right-of-ways or easement of private third parties.
