#### **QUITCLAIM OF FREIGHT EASEMENT**

### KNOW ALL MEN BY THESE PRESENTS:

That UNION PACIFIC RAILROAD COMPANY, a Delaware corporation, Grantor, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration to it duly paid, the receipt whereof is hereby acknowledged, has remised, released and quitclaimed, and by these presents does REMISE, RELEASE and forever QUITCLAIM unto UTAH TRANSIT AUTHORITY, a public transit district organized under Title 17A, Chapter 2, Part 10, Utah Code Annotated 1953, as amended, Grantee, its successors and assigns, forever, all its right, title, interest, estate, claim and demand, both at law and in equity, of, in and to the Railroad Easement applicable to the real estate in the County of Salt Lake, State of Utah, more particularly described in **Exhibit A** attached hereto and hereby made a part hereof (the "Property"), which Railroad Easement was reserved by Grantor in subparagraph (e) of that certain Quitclaim Deed from Grantor to Grantee dated September 16, 2002 and recorded on September 20, 2002 at Entry No. 8360002, Book 8651, Page 3988 in the Salt Lake County Recorder's Office ("Quitclaim Deed").

The aforementioned Railroad Easement automatically terminated as of July 22, 2005, the effective date of a decision by the Surface Transportation Board granting authority for Grantor to abandon its freight rail services on the Property, in accordance with the terms of the Quitclaim Deed and with the provisions of Section 11.1(g) of that certain Purchase and Sale Agreement between Grantor and Grantee dated January 17, 2002, as amended. In the event that Grantor seeks to exercise any rights that it may have under federal law to restart freight rail service on the Property, and Grantee elects not to exercise any rights it may have to acquire those restart rights from Grantor, Grantee shall provide Grantor with rights to access and use the Property to provide such freight rail services under mutually agreeable terms and conditions. The foregoing provision shall constitute a covenant running with the land and shall bind and inure to the benefit of Grantor and Grantee and their respective successors and assigns.
