

# Quit Claim Deed

The UTAH DEPARTMENT OF TRANSPORTATION, by its duly appointed Director, Grantor, of Salt Lake City, County of Salt Lake, State of Utah, hereby QUIT CLAIMS to ZELLA WALCH, OTIS WALCH, HAZEL CAHOON Grantee of Delta, County of Millard, State of Utah for the sum of \$10.00 and other valuable considerations Dollars, the following described parcel of land in Millard County, State of Utah, to-wit:

A parcel of land situate in the SE $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 24, T. 18 S., R. 3 W., S.L.B.&M. The boundaries of said parcel of land are described as follows:

Beginning at the northwest corner of said parcel which point is also the northwest corner of said SE $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 24; thence South 227 ft., more or less, along the west boundary line of said SE $\frac{1}{4}$ SW $\frac{1}{4}$  to a point 100 ft. perpendicularly distant northwesterly from the centerline of survey of a highway known as Project No. FI-67 which point is also a point on the right of way and limited access line of said highway; thence N. 48°00' E. 342 ft., more or less, along said right of way and limited access line to the north boundary line of said SE $\frac{1}{4}$ SW $\frac{1}{4}$ ; thence West 252 ft., more or less, along said north boundary line to the point of beginning. The above described parcel of land contains 0.66 acre, more or less.

The above described parcel of land is granted without access to or from the adjoining highway over and across the northwesterly boundary line of the above described parcel.

Together with and subject to any and all easements, restrictions, and rights of way appearing of record or enforceable in law and equity.

As a covenant to go with the above described parcel of land until January 1, 1976:

1. Signs, billboards, outdoor advertising structures, or advertising of any kind as provided in 23 USC, Section 131, shall not be erected, displayed, placed or maintained upon or within this tract, EXCEPT signs to advertise the sale, hire, or lease of this tract or the principal activities conducted on this land.

2. Junkyards, as defined in 23 USC, Section 136, shall not be established or maintained on this tract.

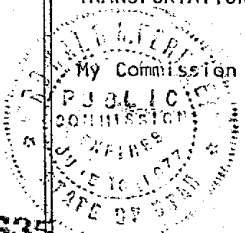
