DEED OF CONVEYANCE

UTAH OIL REFINING COMPANY, a Delaware corporation, GRANTOR, for the sum of TEN DOLLARS (\$10.00) and other good and valuable consideration, receipt of which is hereby acknowledged, by these presents does grant, bargain, sell, convey, and quitclaim to THE AMERICAN OIL COMPANY, a Maryland corporation, GRANTEE, all of the right, title, and interest Grantor may now own or hereafter acquire in and to all of the artesian, percolating, and natural subsurface waters appurtenant or belonging to, underlying and contained in, the so-called City Creek Artesian Basin, and other artesian basins, in whole or in part, underlying Blocks 115, 116, 117, 118, 119, 120, 121, 132, 133, 134, 135, 136, 137, 138, 139, 151, 152, and 153, Plat "A", Salt Lake City Survey; and Blocks 61, 72, 73, 84, 85, 96, and 97, Plat "C", Salt Lake City Survey; and particularly all of the right, title, and interest of said Grantor in and to said artesian, percolating, and natural subsurface waters, appurtenant or belonging to, underlying and contained in, the following described property in the County of SALT LAKE, State of UTAH, to wit:


