THIS MODIFICATION OF DEED OF TRUST dated May 4, 2020, is made and executed between CROSSROADS NOGDEN BP, LLC, whose address is 748 HERITAGE PARK BLVD STE 203, LAYTON, UT 84041-5725 ("Trustor") and First Community Bank Utah, Division of Glacier Bank, whose address is Layton Main Office Branch, 12 South Main, Layton, UT 84041 ("Lender").

DEED OF TRUST. Lender and Trustor have entered into a Deed of Trust dated May 3, 2019 (the "Deed of Trust") which has been recorded in Weber County, State of Utah, as follows:

REAL PROPERTY DESCRIPTION. The Deed of Trust covers the following described real property located in Weber County, State of Utah:

All of Lot 604, NORTH POINTE CENTER SUBDIVISION, SIXTH AMENDMENT, according to the official plat thereof, recorded in the office of the County Recorder of Weber County, Utah on December 28, 2017 as Entry No. 2897475 in Book 82 at Page 58.

The Real Property or its address is commonly known as 2550 North Washington Blvd, North Ogden, UT 84414. The Real Property tax identification number is 18-154-0004.

MODIFICATION. Lender and Trustor hereby modify the Deed of Trust as follows:

Construction Deed of Trust is hereby converted to a term agreement.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Deed of Trust (the "Note"). It is the intention of Lender to retain as liable all parties to the Deed of Trust and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Deed of Trust does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
