## NOTICE OF PRESCRIPTIVE EASEMENT

The MOAB IRRIGATION COMPANY (established 1891) declares and records the following prescriptive easement of **Center Ditch 2** as allowed by Utah Code Title 57 Chapter 13a with the right to inspect, maintain, operate, repair, protect, remove, and replace pipelines, valve boxes, and other associated structures and appurtenances, over, across, under and through the easement. The system may include above and below ground structures, pipelines, and ditches.

The prescriptive easement location is the actual "as built" location of underground pipelines. The following center line description given below is the approximate location based on a survey of above ground structures. The actual underground location may be several feet or more from this center line. Some of the pipelines on Center Ditch 2 are privately owned, but are listed as part of the overall distribution of the irrigation system.

Water Rights 05-2013 and 05-1068 are tied to this easement.

This description does not replace, but does include the description from the easement recorded as Entry 506521, Bk 808 Pg 621-627 on 24 Jun 2014 between Moab Valley Healthcare, Canyonlands Healthcare Special Service District and Moab Irrigation Company.

This description replaces, corrects, and updates the pipeline description recorded as Entry 505241 Book 803 Pg 59-60 as recorded on 10 December 2013
