#### Lease

- 1. The Parties and The Property. DELUXE MANAGEMENT, INC., a Utah corporation, hereinafter referred to as "Lessor", hereby leases to BIG DELUXE-4TH, L.L.C. hereinafter referred to as "Lessee", all those premises situate, lying and being in the County of Salt Lake, State of Utah, commonly known as 730 South State Street, Salt Lake City, UT 84111 and more particularly described in Exhibit "A" which is attached hereto and incorporated herein by this reference (the "Property").
- 2. The Term. TO HAVE AND TO HOLD the Property, together with the appurtenances, unto the Lessee for a term of approximately twenty (20) years commencing August 1, 2012, for and during the latest of ?lease end date or until the SBA 504 Loan under SBA Loan Authorization No. 52343550-08 is paid in full.
- 3. The Lease Payment. - **4.** The Return of the Property. Lessee further agrees to deliver up to Lessor at the expiration of said term in as good order and condition as when the same were entered upon by Lessee, reasonable use and wear thereof and damage by the elements excepted.

  - (b) Lessor and Lessee hereby assign, set over, and transfer to the Small Business Administration and Mountain West Small Business Finance all of their right, title, and interest in and to this Lease, as security for said SBA Loan; and
  - (c) Lessor and Lessee hereby agree to maintain exactly the present ownership (both identity of owners and percent of ownership) during the entire term of said SBA Loan except for ownership changes of up to 5 per cent beginning six months after the SBA 504 Loan closes.
- 13. No Other Agreements. This agreement supercedes and replaces any and all previous lease agreements between the parties; and said previous lease agreements are hereby canceled by the mutual consent of the parties.
