the boundary line herein described; and in consideration of the
payment of one dollar paid by the party of the second part, and
paid to the party of the first part, the party of first part does
hereby Quit Claim any interest he has in and to any property North
of the boundary line herein described.

Beginning at a point on the Westerly line of Highway 106, (a 66

the quarter section line and Northwesterly along said Westerly line
of highway 106, 117.32 feet along the arc of a 3404.87 foot radius
curve to the left through a central angle of 1°58'27" (radius point
bears South 58°07'19" West from the beginning of the curve) to
highway station 468+14.7 and North 33°51'08" West 202.38 feet to
an existing fence and North 33°51'08" West 118.09 feet along said
highway from the Center of said Section 13; and running thence
North 88°57'36" West 260.53 feet.
