RIVERSIDE CROSSING, LOT 1

A portion of the Northeast Quarter of Section 23, Township 5 South, Range 1 West, Salt Lake Base and Meridian, more particularly described as follows:

Beginning at a point on the easterly right-of-way line of Redwood Road (SR-68) located S0°13'38"E along the quarter section line 866.50 feet and East 99.61 feet from the North 1/4 Corner of Section 23, Township 5 South, Range 1 West, Salt Lake Base and Meridian (said point being monumented with a UDOT right-of-way pipe and cap monument); thence N89°57'12"E along the south line of DaImore Meadows Phase 2 Subdivision 552.49 feet; thence South 256.73 feet; thence West 545.59 feet to the easterly line of Redwood Road; thence along said line the following two (2) courses: N2°47'46"W 111.59 feet; thence N0°34'32"W 144.84 feet to the point of beginning.
