Purchasers should confirm with the Company Secretary whether any delinquent assessments exist prior to closing on the purchase of Shares or property receiving irrigation or domestic water based on Shares in the Company. It is the sole responsibility of the purchaser to resolve payment of any delinquent assessments with the current owner of the Shares. Water will not be available for use until a new Share certificate has been issued to the purchaser and all delinquent assessments are paid in full. The Company may also charge a processing fee for the transfer of Shares on its shareholder records.

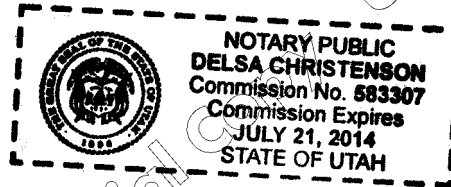

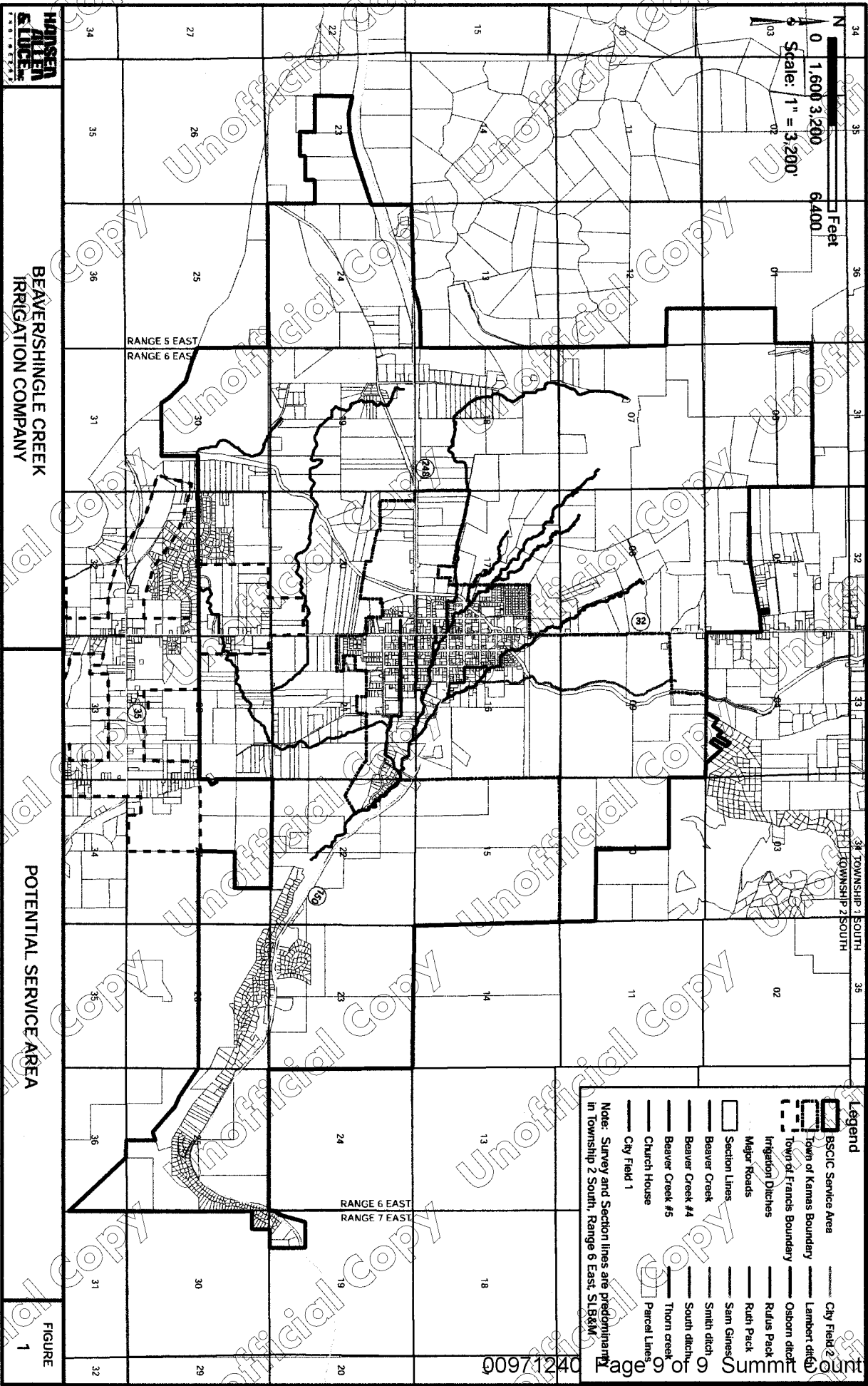
