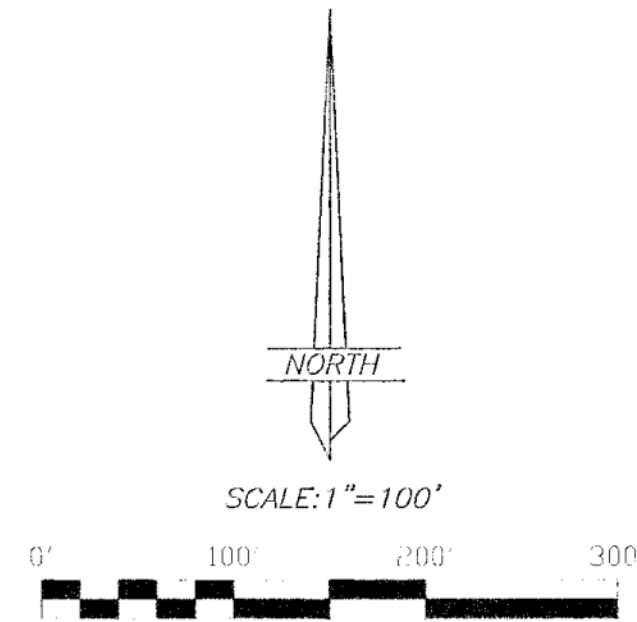

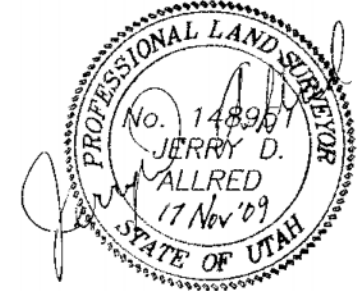
# AMENDMENT TO BANDANNA RANCH CHUCKWAGON PHASE II

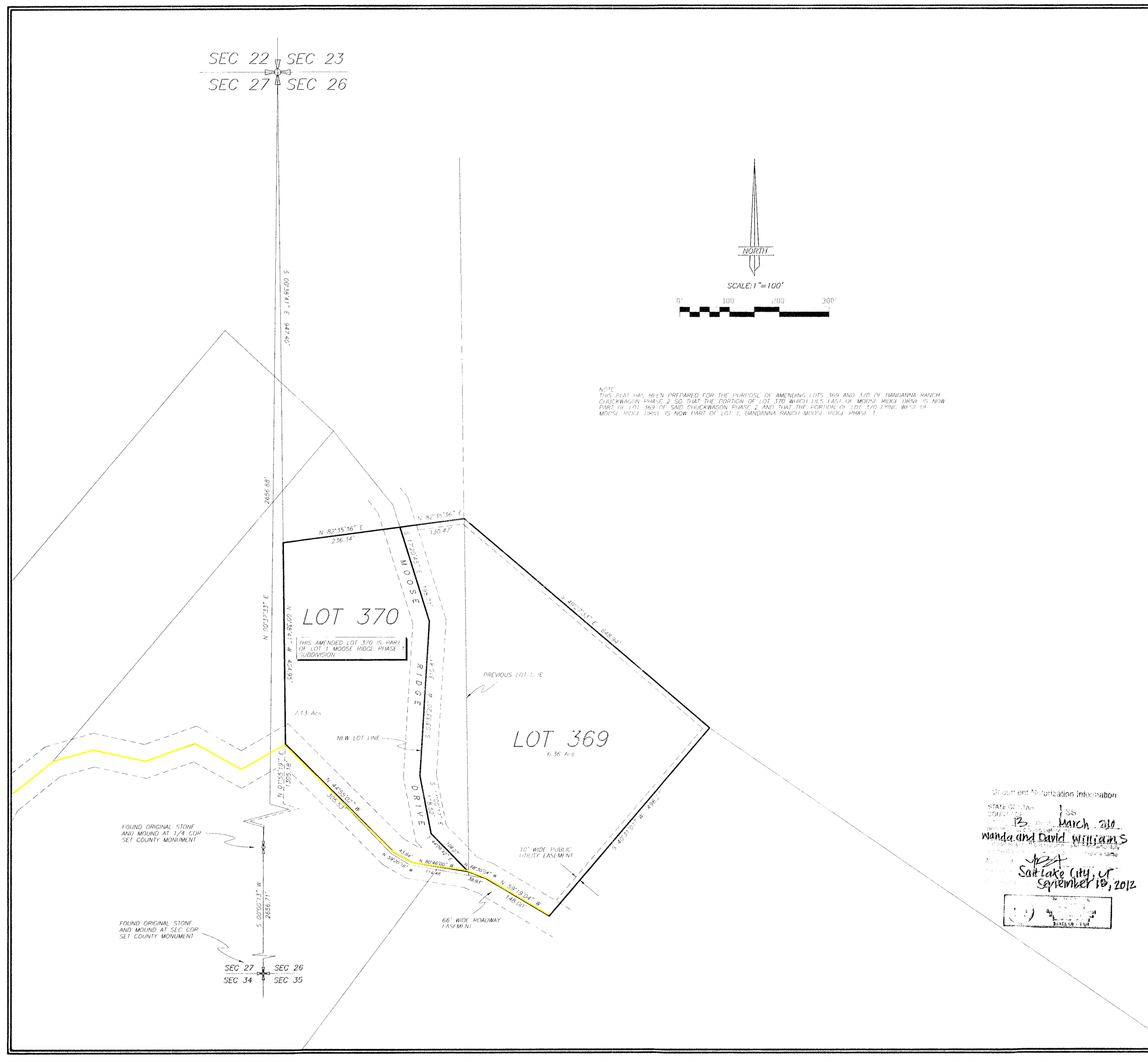
