QUIT CLAIM DEED

KENNECOTT COPPER CORPORATION, a corporation organized and existing under the laws of the State of New York with its principal office at New York City, County of New York, State of New York, Grantor, hereby quit claims to TERRACOR, a Utah corporation, Grantee, of Salt Lake City, Salt Lake County, State of Utah, for the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the following described tracts of land situate in Sections 9 and 10 of T 2 S, R 4 W, Salt Lake Base and Meridian, Tooele County, State of Utah, to-wit:

Begin at the N1/4 corner of Section 16, T 2 S, R 4 W, SLB&M; and running thence S 0° 55'50" E along quarter-section line 85.83 ft. to an existing fence, thence S 88° 27'20" W 330.05 ft., thence N 1° 06'30" W 91.59 ft. to the north line of said section, thence N 89° 27'20" E 330.32 ft. to point of beginning, containing 0.672 acres.

Begin at a fence corner S 0° 55'50" E 85.83 ft. along the quarter-section line from the N1/4 corner of Section 16, T 2 S, R 4 W, SLB&M; and continuing thence S 0° 55'50" E along the quarter-section line 2531.09 ft. to the center of said section 16; thence S 89° 24'40" W along an east-west quarter-section line 322.23 ft. to an existing fence, thence S 1° 06'30" E 119.09 ft. to an existing east-west fence, thence N 88° 54'20" E along said fence 367.55 ft. to an existing north-south fence, thence N 0° 45'30" W along a fence 403.05 ft. to the southerly right-of-way of U.S. Highway 40, thence S 62° 42'15" W 35.0 ft., thence N 01° 18'30" W 2259.76 ft. to point of beginning, containing 1.691 acres, less R/W of U. S. Highway 40.

Begin at a fence line S 89° 24'40" W 322.23 ft. from the center of Section 16; T 2 S, R 4 W, SLB&M; thence N 1° 06'30" W along a fence line and fence line extended 2525.65 ft. to an existing fence, thence S 88° 27'20" W 0.24 ft. thence S 0° 56'15" E 2525.58 ft. to a quarter-section line, thence N 89° 24'40" E 7.77 ft. to point of beginning, containing 0.232 acres less R/W of U. S. Highway 40.

Expressly, excepting, reserving and specifically subject to a perpetual easement, right and privilege on the part of Kennecott, its successors lessees, licensees and assigns, at any time and all times hereafter, to discharge through the medium of the air upon each and every portion of said lands any and all gases, particulates, dusts, dirt, fumes, and other substances and matter which may be released, given or thrown, or blown off, emitted or discharged in the course of, or by, or through the existence or operation of each or all of the smelting plants, reduction works, mills, refineries, power plants, manufactories, tailing deposits and other works or factories which are now or which may hereafter at any time be established or operated by Kennecott, its successors, lessees, licensees, or assigns, or any of them.

Grantor reserves unto itself all gas, oil and mineral rights.

The officers who sign this deed hereby certify that this deed and the transfer represented thereby was duly authorized under a resolution duly adopted by the Board of Directors of the Grantor at a lawful meeting duly held and attended by a quorum.
