This Assignment is subject to a reservation to Ish McKnight of two and one-half per cent (2-1/2%) of all of the oil, gas and petroleum products produced, saved, and marketed from the above lands.

This Assignment is subject, also, to the provisions of the Reassignment Clause affixed as a Rider to that Assignment of Oil and Gas Lease executed on July 18, 1961, by Ish McKnight and Dorothy McKnight, his wife, in favor of J. M. Dunbar, covering the above lands.

and there is also assigned all personal property used or obtained in connection therewith to PAN AMERICAN PETROLEUM Corporation and its heirs, successors and assigns.

And for the same consideration, the undersigned for himself and his heirs, successors and representatives, do hereby covenant with the said assignee its heirs, successors, or assigns that he is the lawful owner of the said lease and rights and interests thereunder and of the personal property thereon or used in connection therewith; that the undersigned has good right and authority to sell and convey the same, and that said rights, interest and property are free and clear from all liens and incumbrances, and that all rentals and royalties due and payable thereunder have been duly paid; and that the undersigned will warrant and defend the same against the lawful claims and demands of all persons whomsoever.
