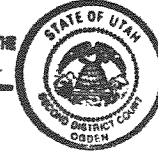





16 This matter came before this Court for a jury trial between May 31-June 13, 2017. The
17 parties presented testimony, exhibits, and arguments to the jury, which began deliberations on June
18 13, 2017. The jury rendered a verdict on June 14, 2017.

19 The jury having rendered its verdict that the total of damages to Plaintiff William L.
20 Baughn is \$2,550,000; and that that Defendant Staker & Parson Companies was 60% at fault,
21 Plaintiff William L. Baughn was 25% at fault, and Plaintiff William L. Baughn's employer BDR
22 Transport was 15% at fault; the damages determined which are Staker & Parson Companies'
23 responsibility and proper for inclusion as a judgment is \$1,530,000 against Staker Parson &
24 Companies.

1 Accordingly, the Judgment of this Court is that there are damages and costs assessed in




