## EASEMENT

THIS INDENTURE, made this 13th day of April, 1934, between JAMES WIGNALL and HARRIET BURT WIGNALL, his wife, Grantors, both of Utah County, State of Utah, and SPRINGVILLE IRRIGATION COMPANY, a corporation, of the State of Utah, Grantee, witnesseth:-

Whereas, the Grantors above named are seized in fee of certain parcels of land situate in Utah County, State of Utah, and more particularly described as follows: to-wit:

And, Whereas, the grantee herein desires to construct a connecting ditch between the High Line Canal and the Head of District #2 Canal and the course of said ditch does cross the said lands in a Southerly direction.

Now this Indenture, witnesseth, that in pursuance of this agreement and in consideration of the sum of One dollar and other valuable consideration, now paid by the said grantee to these grantors, the receipt of which is hereby acknowledged, the said grantors, hereby grant unto this grantee, its successors and assigns forever, the free right to construct and use the said ditch across said grantors' land, and reasonable access to said land for the keeping of said ditch in proper repair; and for this purpose the grantee shall forever hereafter maintain said ditch in proper repair and in such a condition that it will do no unreasonable damage to the property of said Grantors, their successors or assigns, except such damage as would reasonably be caused to said land by said ditch flowing across and through said lands.
