The owners voted on an amendment to the Bylaws by a vote of 81, 82 or 85 'for' votes on three tally sheets, total ballots 109. This calculates to some place between 73% to 77 %, minimum required is 67%. Please find the approved amendment below. Please record the amendment for:

FOREST GLEN — PHASE I through VI, A CONDOMINIUM

The May 2004, 2.3 Bylaw reads:

2.3 Special Meeting. Special meetings of the members may be called at any time by the President or by the Board of Directors. Special meetings of the members may also be called by written notice signed by not less than one-third (1/3) of all members stating the issues proposed to be considered at the proposed special meeting and/or the purpose for which said special meeting is to be held, dated and delivered to the corporation's secretary and all members not less than fifteen (15) days prior to the date fixed for said special meeting.

The amended 2.3 Bylaw reads:

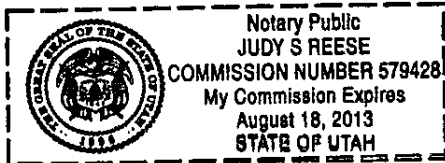
2.3. Special Meetings. Special meetings of the members may be called at any time by the President or by the Board of Directors. Special meetings of the members may also be called by the Board after receiving written demands signed by at least 10% of all members stating the issues proposed to be considered at the proposed special meeting and/or the purpose for which said special meeting is to be held, dated and delivered to the corporation's secretary. If a notice for a special meeting demanded by owners (as described above) is not given by the Board pursuant to Bylaw 2.5 within 30 days after the date the written demand is delivered to the secretary, a person signing the demand may

- (a) set the time and place of the meeting and
- (b) give notice pursuant to Bylaw 2.5, and
- (c) the Board will then conduct the special meeting (or prepare the written ballots and information for the owners, deliver or mail them, and count the votes).
