

Beginning at a point 33.00 feet South 89°54'38" East along the Section Line from the Southwest Corner of said Section 36; and running thence North 0°08'39" West 703.99 feet along the East Line of 5600 West Street as it exists at 33.00 foot half-width to a point on the South Boundary of future Herriman Village P.U.D. Subdivision; thence along said South Boundary the following four courses: North 89°51'21" East 246.00 feet to a point of curvature; Northeasterly along the arc of a 165.00 foot radius curve to the left a distance of 47.64 feet (Central Angle equals 16°32'38" and Long Chord bears North 81°35'02" East 47.48 feet); South 51°12'26" East 171.83 feet; and East 316.88 feet to the Southeasterly Corner thereof; thence South 605.06 feet to the Section Line; thence North 89°54'38" West 742.00 feet along said Section Line
