## **BOUNDARY LINE AGREEMENT**

(Survey)

AGREEMENT, made and entered into this 16th day of October, 2015, by and between Bruce Lloyd Goodwin and Vera C. Goodwin, husband and wife as joint tenants with full rights of survivorship, Party of the First Part, as their interest appear herein, any and all right, title and interest which said parties of the Second Part may have in and to all the land in the possession of the said Party of the First Part, lying within the boundaries of the afore-described survey, being the parcel of land in possession of the said Bruce Lloyd Goodwin and Vera C. Goodwin, husband and wife as joint tenants with full rights of survivorship, Party of the First Part, hereinabove described.
