POLE LINE EASEMENT

G. Taylor Burton and Hilda H. Burton
 his wife, Grantor.S., of Weber County, Utah, hereby convey... and warrant...
 to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns,
 Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement
 and right of way for the erection and continued maintenance, repair, alteration, and replacement
 of the electric transmission, distribution and telephone circuits of the Grantee, and
 4. guy anchors and 8 poles, with the necessary guys, stubs, crossarms and
 other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and
 maintained upon and across the premises of the Grantor.S., in Weber County,
 Utah, along a line described as follows:

Beginning at the east boundary fence of the Grantors' land at a point 700 feet
 north and 2725 feet west, more or less, from the southeast corner of Section 29,
 T. 7 N., R. 1 E., S.L.M., thence S. 0° 12' W. 150 feet, more or less, thence
 S. 0° 09' E. 407 feet, thence S. 21° 17' E. 367.5 feet, thence S. 12° 50' E. 331
 feet, thence S. 52° 01' E. 335.5 feet, thence S. 12° 07' E. 280 feet, more or
 less, to a southeasterly boundary line of said land and being in the SE 1/4 of the
 SW 1/4, the SW 1/4 of the SE 1/4 of said Section 29 and the NW 1/4 of the NE 1/4
 of Section 32, Township and Range aforesaid.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
