Assignor shall indemnify and hold Assignee harmless from and against any and all claims, costs, demands, losses, damages, liabilities, lawsuits, actions and other proceedings in law or in equity or otherwise, judgments, awards and expenses of very kind and nature whatsoever, including without limitation, attorneys' fees, arising out of or relating to, directly or indirectly, in whole or in part, the Development Agreement occurring prior to the Closing Date.
- 7. <u>Modifications</u>. This Assignment may not be modified, altered or amended, or its terms waived, except by an instrument in writing signed by the parties hereto.
- 8. <u>Counterparts & Facsimiles</u>. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Facsimile signatures shall be deemed valid and enforceable.
- 9. <u>Governing Law</u>. This Assignment shall be governed by and construed in accordance with the laws of the State of Utah.
- 10. <u>Attorneys' Fees</u>. In the event any dispute between the parties hereto should result in litigation, the prevailing party shall be reimbursed for all reasonable costs, including but not limited to, reasonable attorneys' fees.
