SMOOT BROTHERS JERSEY FARM, a Utah corporation Grantor, of Salt Lake City, State of Utah, hereby Quit Claims to WASATCH GAS COMPANY, a Utah corporation, Grantee of Salt Lake City, State of Utah, its successors and assigns for the sum of SIXTY TWO AND NO/100 Dollars, the right of way to lay, maintain, operate and remove pipe lines with the right of ingress and egress to and from said right of way, over and through the following described tract of land in Township 3 North, Range 1 West, Salt Lake Base and Meridian, in the County of Davis, State of Utah, bounded and described as follows:

That part of the Northwest quarter of Section 25, and part of the South half of Section 14, now owned by Smoot Brothers Jersey Farm.

The said Grantor, to fully use and enjoy the said premises except for the purpose hereinbefore granted to the said Grantee, which hereby agrees to pay damages which may arise to crops or fences from the laying, erecting, maintaining, operating or removing of said pipe lines; said damages, if not mutually agreed upon, to be ascertained and determined by three disinterested persons, one thereof to be appointed by the said Grantor, its heirs or assigns, one by the said Grantee, its heirs or assigns, and the third by the two so appointed as aforesaid.
