for the use of the plaintiff, the State of Utah, for highway purposes.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that said use is a public use and a use authorized by law.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that a copy of this final order of condemnation be filed with the county recorder of Weber County, State of Utah, and thereupon the property interests hereinafter referred to and set forth shall vest in fee simple title as to Parcel Nos. 106:A, 106B:A, and for easement rights as to Parcel No. 106:E in the plaintiff. The following is a description of the property so ordered and condemned as hereinabove provided, which is hereby vested in fee simple title as to Parcel Nos. 106:A, 106B:A and for easement rights as to Parcel Nos. 106:E in the plaintiff, all of such property being situated in Weber County, State of Utah, and is more particularly described as follows:

Parcel No.15-8:106:A

A parcel of land in fee for a freeway known as Project No. 15-8, being part of an entire tract of property, in the E½ NE¼ of Section 11, T. 6N., R. 2W., S.L.B. &M. Said parcel of land is contained within two side lines parallel to and at distances of 120.0 ft. westerly and 120.0 ft. easterly from the center line of said project. Said center line is described as follows:

Beginning at the intersection of the south boundary line of said entire tract and said center line approximately at Engineer Station 1318+11, which point is approximately 461 ft. north and 205 ft. west from the E½ corner of said Section 11; thence N. 01° 05' E. 1157 ft., more or less, to the intersection of said center line approximately at Engineer Station 1329+68 and the center line of a county road.

The above described parcel of land contains 6.37 acres, more or less, of which 0.08 acre, more or less, is now occupied by said county road. Balance 6.29 acres, more or less.

Together with any and all rights or easements appurtenant to the remaining portion of said entire tract of property by reason of the location thereof with reference to said freeway, including, without limiting the foregoing, all rights of ingress to or egress from said remaining portion contiguous to the lands hereby conveyed, to or from said freeway.

Two parcels of land in fee for a freeway known as Project No. 15-8, being part of an entire tract of property, in the E½NE¼ of Section 11, T. 6 N., R. 2 W., S.L.B. & M. The boundaries of said parcel of land are described as follows:

Beginning at a point 120.0 ft. perpendicularly distant easterly from the center line of said project opposite Engineer station 1329+00, which point is approximately 1555 ft. north and 82 ft. west from the E½ corner of said Section 11; thence S. 1° 12' E. 500.40 ft.; thence S. 2°11' E. 592 ft., more or less, to the south boundary line of said entire tract; thence West 50 ft., more or less, along said south boundary line to a point 120.0 ft. perpendicularly distant easterly from said center line; thence N. 1°, 05' E. 1089 ft., more or less, to the point of beginning.

ALSO:

Beginning at a point 120.0 ft. perpendicularly distant westerly from said center line opposite said Engineer Station 1329+00, which point is approximately 1555 ft. north and 322 ft. west from the E4 corner of said Section 11; thence S. 2°02' W. 600.08 ft.; thence S. 5°51' W. 497 ft., more or less, to the south boundary line of said entire tract; thence East 50 ft., more or less, along said south boundary line to a point 120.0 ft. perpendicularly distant westerly from said center line; thence N. 1°05' E. 1089 ft., more or less, to the point of beginning. The above described parcels of land contain 1.00 acre, more or less.

Together with any and all rights or easements appurtenant to the remaining portion of said entire tract of property by reason of the location thereof with reference to said freeway, including, without limiting the foregoing, all rights of ingress to or egress from said remaining portion; contiguous to the lands hereby conveyed, to or from said freeway.

An easement upon part of an entire tract of property in the $E_2^1NE_2^1$ of Section 11, T. 6 N., R. 2 W., S.L.B. &M., in Weber County, Utah, for the purpose of constructing thereon an irrigation facility and appurtenant parts thereof incident to the construction of a freeway known as Project No. 15-8.

said part of an entire tract is a parcel of land 20.0 ft. wide adjoining westerly the following described portion of the westerly no access line of said project.

Beginning at a point 120.0 ft. perpendicularly distant westerly from the center line of said project opposite Engineer Station 1329+50, which point is approximately 1610 ft. north and 323 ft. west from the E4 corner of said Section 11; thence S. 1 05' W. 50.0 ft.; thence S. 2 02' W. 600.08 ft.; thence S. 5 51' W. 497 ft., more or less, to the south boundary line of said entire tract. The above described parcel of land contains 0.53 acre, more or less.

A temporary work easement to facilitate the construction

of said irrigation facility and appurtenant parts thereof, being upon a parcel of land 20.0 ft. wide, adjoining westerly the westerly side line of the above described easement, containing 0.53 acre, more or less.

The above described temporary work easement shall expire upon the completion of said construction.
