**QUIT-CLAIM DEED**

**NORTH DAVIS COUNTY SEWER DISTRICT**, a Special Improvement District organized and existing under the laws of the State of Utah, with its principal office at Syracuse City, County of Davis, State of Utah, Grantor, hereby QUIT CLAIMS to:

**SYRACUSE CITY**, a municipal corporation of the State of Utah, Grantee, for the sum of ONE DOLLAR (\$1.00) and other good and valuable consideration the following described sewer pipeline and appurtenant easements in connection therewith, if any,:

A part of Sections 21 and 28, Township 4 North, Range 2 West, Salt Lake Base and Meridian, United States Survey.

Beginning at a point on the intersection of the old Metropolitan 24" sewer main and the North Davis County Sewer District Outfall Main, said point being South 2400 feet more or less and West 5 feet from the Northeast corner of said Section 21; Running thence South 5490 feet more or less parallel to the East lines of Sections 21 and 28 to the end of the 24-inch sewer main; and, as per plat attached hereto and made a part hereof.

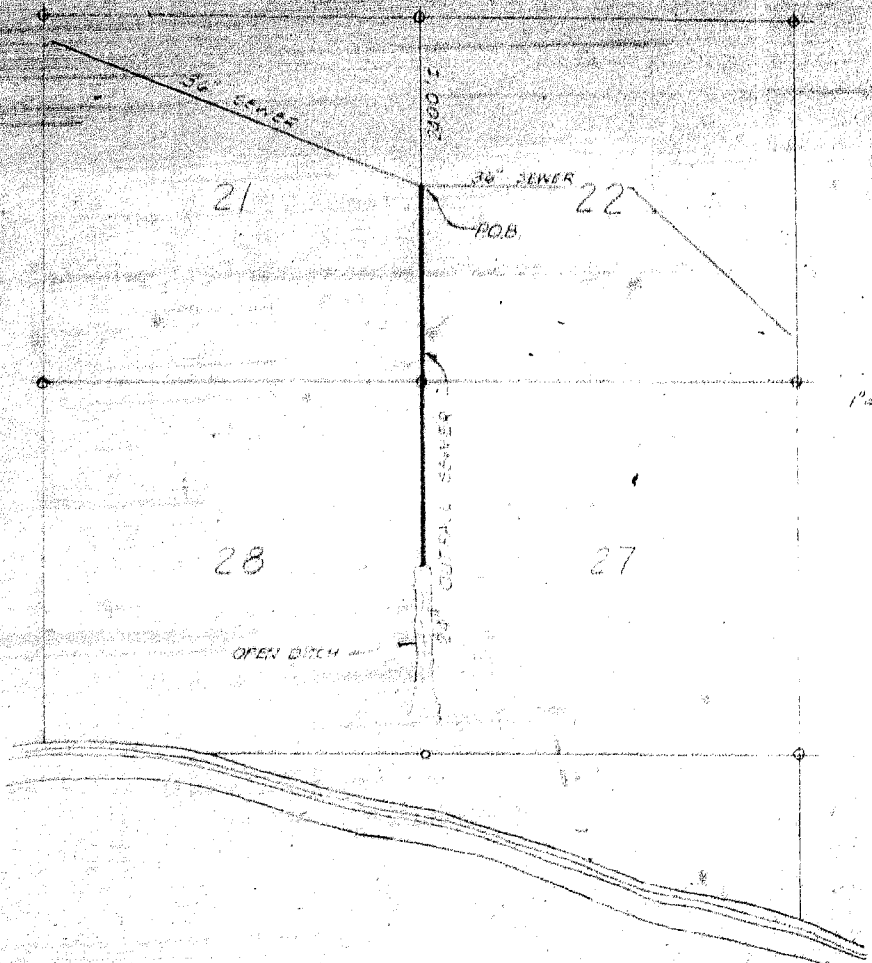
