## KNOW ALL MEN BY THESE PRESENTS:

In consideration of One Dollar (\$1.00) and other good and valuable consideration paid to THOMAS J. LORDEN and BARBARA LORDEN hereinafter referred to as "Grantors," by the City of St. George, City of Santa Clara, and the Town of Ivins, hereinafter referred to as "Grantees," Grantors do hereby grant, transfer and convey unto the Grantees both a temporary easement and a perpetual easement with the right to erect, construct, install and lay, and thereafter a perpetual easement to use, operate, inspect, repair, maintain, replace of expand sewer facilities, including but not limited to large diameter outfall lines, a service road, and possibly the placement of rip-rap, steel or concrete structures, under and along any portion of the property described herein which may be owned by Grantors in Washington County, State of Utah.

The temporary easement shall be 50 feet in width during the period of construction, and upon completion, the perpetual easement shall be 30 feet in width, the centerline of both the temporary and perpetual easements is described in Exhibit "A", attached hereto and incorporated herein by this reference.

Grantees agree to maintain the easement in good repair so that Grantors can continue to make such use of the surface of said easement as does not interfere with its purposes as described herein, and in such a manner that no damage results to the adjacent land of Grantors. Grantors shall provide reasonable ingress and egress to and from said right-of-way.

The benefits of this easement shall inure to the benefit of Grantees, or any municipal successor thereof, but shall not inure to or be for the benefit of any private assignee of Grantees.

The legal description of the property effected by the aforesaid Right-of-Way Easement is particularly described as follows:

All of Lot 3, Block 28, ST. GEORGE AND SANTA CLARA BENCH IRRIGATION SURVEY OF LANDS situated in Section 9, T42S., R16W., SLB&M, and as shown on the official map of said survey on file in the office of the recorder of Washington County, Utah.

LESS AND EXCEPTING the Westerly 1/3 of said lot and also LESS AND EXCEPTING the Easterly 1/3 of said Lot 3 containing an aggregate of 3 1/3 acres of land more or less.

TOGETHER with all improvements thereon, and all appurtenances thereunto belonging.

TOGETHER with 0.014 c/f/s underground water right in and to the application to the appropriate Water No. 36876, on file at the offices of the Division of Water Rights of the State of Utah.

SUBJECT to easements, rights-of-way, covenants and conditions enforceable in law and equity.
