WHEREAS, D.I.C. ESTATE, L.C. (the "Company") is a Utah limited liability company,

consisting of the following members and membership interests as of the date of this Agreement:

JAY B. DANSIE

28.5% Interest

MARLEEN F. DANSIE

25% Interest

LARUE L. DANSIE

46.5% Interest;

WHEREAS, LaRue L. Dansie is desirous of receiving a One Hundred Thousand Dollar (\$100,000.00) disbursement from the Company for her personal use;

WHEREAS, the Company currently has available cash on hand to make a disbursement to its members such as would result in LaRue receiving the \$100,000.00 she desires, HOWEVER in doing so, the Company's Manager, Ryan F. Dansie, has advised that the Company's cash and savings reserves would be depleted to an extent that would not be desirable for the future operations of the Company;

WHEREAS, Jay B. Dansie and Marleen F. Dansie are willing to leave their respective shares of the disbursement in the Company for the time being, in the form of a demand note to assist in the future operations of the Company;

THEREFORE, based on the foregoing, and other good and valuable consideration, the undersigned members, being all of the members of Company, do hereby agree to a distribution of Company assets in accordance with the terms and conditions of this Distribution Agreement:

1. <u>Distribution Amount</u>. The Company shall make a one-time distribution of Two Hundred Fifteen Thousand Fifty-Three Dollars and Seventy-Six Cents (\$215,053.76) (the

"Distribution") to its members in accordance with their respective membership interests as follows:

a. Distribution to LaRue L. Dansie:

\$100,000.00

b. Distribution to Jay B. Dansie:

\$61,290.32

c. Distribution to Marleen F. Dansie:

\$53,763.44.

2. Form of Payment. The members desire to receive their respective shares of the Distribution in the following form, each of which have been unanimously agreed to by all of the members:

- a. LaRue L. Dansie shall receive her share of the Distribution in the form of a check in the amount of \$100,000.00 from the Company;
- b. Jay B. Dansie shall receive his share of the Distribution in the form of a demand note from the Company in the amount of \$61,290.32, which note shall be payable on demand by Jay B. Dansie, his successors, heirs or assigns, and which shall accrue interest at the rate of 3.75% per annum, which is the current Wall Street Journal Prime Rate ("WSJ Prime Rate") plus 0.50%, and which rate shall be adjusted annually on February 1st to reflect the then current WSJ Prime Rate plus 0.50%;
- c. Marleen F. Dansie shall receive her share of the Distribution in the form of a demand note from the Company in the amount of \$53,763.44, which note shall be payable on demand by Marleen F. Dansie, her successors, heirs or assigns, and which shall accrue interest at the fixed rate of 3.75% per annum, which is the current WSJ Prime Rate plus 0.50%, and which rate shall be

adjusted annually on February $1^{\rm st}$ to reflect the then current WSJ Prime Rate plus 0.50%.


3. <u>No Impact on Membership Interests</u>. The Distribution shall not have any impact on the respective membership interests of the members, which shall remain fully intact as set forth above.
