## Legal Description

Proposed Parcel No. 100:TQ

A tract of land, being part of an entire tract of property situate in Lot 11, Plat "B", North Ogden City Survey, recorded in Book 5 at Page 79 of Plats in the office of the Weber County Recorder, a subdivision in the Northeast quarter of the Northeast quarter of Section 32, Township 7 North, Range 1 West, Salt Lake Base and Meridian. The boundaries of said tract of land are described as follows:

Beginning at the Southwest corner of said entire tract in the Easterly right of way line of Washington Boulevard (400 East Street) which corner is 66.00 feet North from the Southwest corner of said Lot 11 and running thence North 68.50 feet along said Easterly right of way line to a point 96.50 feet perpendicularly distant Southerly from the 2600 North Street control line opposite approximate engineer station 00+65.59; thence North 45°10'03" East 40.60 feet to a line parallel with and 68.00 feet perpendicularly distant Southerly from said control line opposite engineer station 00+94.50; thence North 89°45'15" East 79.21 feet along said parallel line to the Easterly boundary line of said entire tract; thence South 97.00 feet along said Easterly boundary line to the Southeast corner of said entire tract; thence South 89°45'15" West 108.00 feet along the Southerly boundary line of said entire tract to the point of beginning as shown on the official map of said project on file in the office of North Ogden City.
