Jeff Spangler and Brent Tanner agree to a negotiated buyout of Jeff Spangler's note of \$3.5 million dollars at Harmony Ridge Commercial along with all the rights, positions, and interest attached to it. Brent Tanner agrees that for this note he will give up to Jeff Spangler 29% percent of his 50% interest in Commerce Ridge, LLC. Brent Tanner will remain as the sole Manager of Commerce Ridge, LLC with the corresponding rights and responsibilities. An Amended Operating Agreement has been created for Commerce Ridge, LLC showing the changes in personal ownership that has occurred because of the buyout of the Spangler note. To summarize, Jeff Spangler upon execution of this agreement will own 79% of Utah County Parcel 58:002:0174 which is an 11.73 acre Parcel of Commercial/High Density land in Traverse Mountain.
