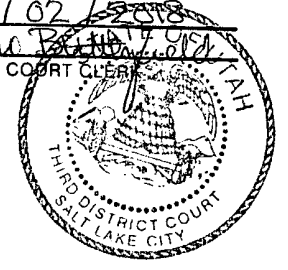

2. For plaintiff's cost incurred herein in the sum of \$230.00.

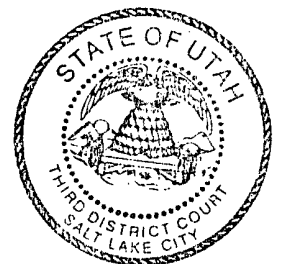
