EASEMENT

An easement and right-of-way consisting of a strip of land being described as follows: Beginning at a point on the Southerly line of the Western Pacific Railroad Right-of-Way said point being 1,084.85 fert more or less South 0°01'17" West along the section line from the Northwest Corner of Section 12, Township 1 South, Range 2 West, Salt Lake Base and Meridian, thence South 0°01'17" West along the section line 4-12 11 4,195.149 feet more or less to the Southwest Corner of said Section 12, thence East 70.0 feet, thence North $0^{\circ}01'17$ " East parallel to the West line of said Section, 4,148.50 feet, thence East 10.0 feet, thence North 0°01'17" East 64 feet more or less to the Southerly line of said Railroad Right-of-Way thence South 77°47' West 81.96 feet to the point of beginning.
