EASEMENT AGREEMENT

THIS EASEMENT is made and entered into this 2 day of Oato Section 2012 by and between 7. Elau and Lehi City Corporation, Grantee, hereinafter referred to as "City."

WITNESSETH:

WHEREAS, the City is desirous to install and maintain a 1" Pressurized Irrigation service across the property described in Exhibit "A" (hereinafter referred to as the "Premises"); and

WHEREAS, Owner is willing to grant a permanent easement through the Premises for access to and the installation, maintenance, and repair of the 1" Pressurized Irrigation service; and

WHEREAS, the easement will also allow the City to reconnect an existing service that was inadvertently disconnected during the reconstruction of main street; and

NOW, THEREFORE, for Ten Dollars and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Owner hereby grants the following easement to City:

- 1. A permanent easement across, under, and through the Premises as described in Exhibit "A" which is attached hereto and by this reference incorporated herein and made a part hereof.
- 2. City's agents and employees shall have the right of ingress to and egress from said easement across the Premises at all reasonable times for installation, maintenance and repair purposes.

Owner understands and agrees that this is a COVENANT RUNNING WITH THE LAND which is binding upon it, its heirs, executors, assigns or other holders of title or interest in the Premises and this Easement will be recorded.

4. In return for Owner granting City this easement, City agrees to hold Owner and Owner's officers, agents, representatives and employees, harmless, and to defend Owner against all claims, damages, losses, liabilities, including but not limited to attorneys' fees, arising out of or resulting from City's access, installation, maintenance, and repair of the 1" Pressurized Irrigation service in the Premises.
