## DEFAULT JUDGMENT

## [SHIEKH MAQBOOL AHMED, FAHMIDA KHANUM AHMED, & AVAIS A. AHMED]

Based on the Plaintiff's Motion for Default Judgment, the Default entered in this Action

against the Defendants, all pleading in this matter, and for good cause appearing, therefore:

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the Plaintiff is found to be entitled to judgment against the Defendants and that Plaintiff's Motion for Default Judgment is hereby GRANTED.

IN SO ORDERING, this Court finds that the Defendants, Shiekh Maqbool Ahmed,

Fahmida Khanum Ahmed and Avais A. Ahmed, have caused the Plaintiff actual damages in the

amount of sixty-five thousand, eighty dollars and fifty-eight cents (\$65,080.58) as of April 1, 2020.

This Court finds that the parties represented that the Note which they delivered to Plaintiff would be secured by property located at 4226 S. 225 E., Kaysville, Utah 84037 ("Property") by a Deed of Trust.

The Court finds that the Defendants, Shiekh Maqbool Ahmed and Fahmida Khanum Ahmed, did not cause that the Deed of Trust was recorded against the Property and sold the Property resulting in the Note not being secured as promised by the Defendants, Shiekh Maqbool Ahmed and Fahmida Khanum Ahmed.

The Court finds that the Defendant, Avais A. Ahmed, represented that the loan would be secured by the Deed of Trust and personally represented to the Plaintiff that he would personally cause the Deed of Trust to be recorded against the Property and yet never did record the Deed of Trust and then made numerous misrepresentations regarding the status of the Deed of the Trust and covered up the fact that the Property had been sold without paying the Note.

The Court finds, by clear and convincing evidence, that the actions of the Defendants, Shiekh Maqbool Ahmed, Fahmida Khanum Ahmed, and Avais A. Ahmed, were tortious misrepresentations that caused the Plaintiff actual damages and thus constitute FRAUD.

The Court finds that the tortious misrepresentations of the Defendants, Shiekh Maqbool Ahmed, Fahmida Khanum Ahmed, and Avais A. Ahmed, were made willfully, intentionally, and undertaken with malice and/or conscious disregard for Plaintiff's rights and that, therefore, the Plaintiff is entitled to PUNITIVE damages.

The Court finds further that the Plaintiff should be entitled to an equitable and

constructive trust on the funds from the sale of the Property, whether remaining in cash or otherwise, used to purchase real property.

Therefore, based on these findings, IT IS FURTHER ORDERED, ADJUDGED AND DECREED that JUDGMENT is awarded in favor of Plaintiff and against *all* Defendants, Shiekh Maqbool Ahmed, Fahmida Khanum Ahmed, and Avais A. Ahmed, *jointly and severally*, in the amount of sixty-five thousand, eighty dollars and fifty-eight cents (\$65,080.58) as of April 1, 2020.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that JUDGMENT is awarded in favor of Plaintiff and against *all* Defendants, Shiekh Maqbool Ahmed, Fahmida Khanum Ahmed, and Avais A. Ahmed, *jointly and severally*, for punitive damages in the amount of sixty-five thousand, eighty dollars and fifty-eight cents (\$65,080.58) awarded to punish the fraudulent misrepresentations of said Defendants in relation to the Deed of Trust and thereafter.

Therefore, IT IS FURTHER ORDERED, ADJUDGED AND DECREED that that the principal amount of this Judgment shall be in the amount of one hundred thirty thousand, one hundred sixty-one dollars and sixteen cents (\$130,161.13) and shall be awarded against *all* Defendants, Shiekh Maqbool Ahmed, Fahmida Khanum Ahmed, and Avais A. Ahmed, *jointly and severally*.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that this Judgment against Defendants, Shiekh Maqbool Ahmed & Fahmida Khanum Ahmed, imposes an EQUITABLE AND CONSTRUCTIVE TRUST in favor of Plaintiff upon the proceeds from the sale of the Property including and against any real property for which the Defendants used funds from the Property (for the purchase or improvement), and should have been used to pay the Plaintiff.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that this Judgment arises from the fraudulent conduct of *all* Defendants, Shiekh Maqbool Ahmed, Fahmida Khanum Ahmed, and Avais A. Ahmed.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that *all* the Defendants, Shiekh Maqbool Ahmed, Fahmida Khanum Ahmed, and Avais A. Ahmed, jointly and severally, shall pay to the Plaintiff the entire amount of **one hundred thirty thousand, one hundred sixty-one dollars and sixteen cents (\$130,161.16)**, which amount includes punitive damages against Defendants plus actual damages.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that this Judgment shall accrue interest at the contractual rate of eighteen percent (18%) per annum.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that this Judgment may be augmented in the amount of reasonable costs and attorney's fees expended in the collection of said Judgment.
